A late filing fee of \$25 per month shall be added to all late-filed tax reports in addition to interest and penalities. The date of actual receipt not the postmark shall determine the date of filing returns.									
A penalty equal to five percent of the delinquent tax shall be added to the tax for the first month or fraction thereof, until a total of 20% of delinquent tax has been reached. In addition to the above penalty, interest shall accrue at the rate of fifteen percent per annum on the delinquent tax from the date of delinquency. Fees, penalty and interest incorrectly calculated will be invoiced for the difference and is immediately due and payable.
